THURSDAY, SEPTEMBER 21, 2006

The colors were presented by the NY State Honor Guard and former agent Emmett McNamara was congratulated on his 97th birthday.

NY SAC Mark Mershon introduced NY Police Commissioner Ray Kelly who praised the FBI for their close partnership with the 40,000 NY police men.

The Keynote speaker at the breakfast was Deputy FBI Director John Pistole who said it was a privilege to be in NYC, the safest city in the US. He talked about the 3 B's: Be Sincere...Be brief... Be seated..... He told how the world and the FBI changed on 9-11. He spoke of intelligence collection, and analysis and the many Field Intel-

ligence Groups and the National Security Branch of the FBI. He mentioned the weekly review of Sentinel, the Bureaus new computer program under development. He mentioned that the FBI has over 100 Joint Task Forces involving Federal, state and local officers. He talked about change and the realigning of 30,000 FBI employees, 396 Resident Agencies and 57 Legats. He stated that the "heart of the FBI will not change".

The Webster Award was presented to GEORGE GREEN of the Baltimore Division for his public service. \$5000 check was presented for the Charity of his choice. Ed Bodigheimer talked briefly of the Orlando Convention in 2007

Foundation Chairman Robert Gast presented the JEH award to St Francis College. For retired agents who attended St Francis College were present: Ed O'Brien, Bill Whelan, Dan Blake and Tom Pickard.

In the afternoon a NY Tour Seminar, SAMBA Seminar and a Financial Seminar were well attended. Society Web Training was also available.

An evening Dinner Cruise was conducted on two ships, one the New York and the other the New Jersey. The food and entertainment were first class and a good time was had by all.

## FRIDAY, SEPTEMBER 22, 2006

Friday began with a continental breakfast, followed by a series of tours: NYC Highlights tour included a visit to Ground 0, the Ellis Island tour, Brooklyn Botanical Gardens tour, and the tour of SOHO-Greenwich Village. A power Point presentation concerning xgboys, the retired agents listserv was well attended and several new members were recruited.

SATURDAY, SEPTEMBER 23, 2006

Saturday began with a continental breakfast where many had a chance to meet old and new friends. The annual business meeting started promptly at 8:30 am with a Call to order by Scott Erskine and the Presentation of colors by the Ramapo NY Police Dept. Father John Hurley gave the invocation. The NY convention committee, and the Past Presidents of the Society were recognized as well as the National Committee Chairmen, Chapter Delegates, and First time attendees, and the Society Staff personel.

Guest Speaker, FBI Director Robert Mueller II was introduced. He spoke on three main topics:

1. Balance needed between Security and Criminal investigations 2, Future of the Bureau 3. Growth of the Bureau since 9-11.

Concerning growth he mentioned that we now have 12,500 Special Agents and 30,000 FBI employees including numerous Intelligence Analyst. The FBI Budget has gone from 3.2 Billion (2001) to 6 Billion in 2006. He mentioned the great legacy that our predecessors have bestowed on us and he thanked all who came before to make the FBI what it is today. Director Mueller answered several questions concerning HR 218, the right to carry, Sentenel, the 5 year Supervisor rule, etc.

The Lou Peters award went to Mike Ghaderi, for his 6 years of sacrifice in operation "White Tiger" a major Heroine case in the Baltimore area. Ghaderi suffered many hardships and was placed under witness protection. He stated that you do not have to be born here to love this country". A series of Society reports were made and the change of command was made between Jerry Emmons to Andy Palumbo, our New President.

On Friday afternoon there was a Fur fashion show, showing the latest in Fall Furs.

Erskine advised that 3800 Retired Credentials had been furnished since February 2006. Only 68 credentials remain but require a credential number or photograph. Identification card and the right to carry was thoroughly discussed. Each state seems to have a different problem but firearms certification is needed as well as an ID card in order to carry a weapon. The Bureau issues the ID card. The group discussed the possibility of one Humanitarian award (\$10,000) Don Witham, editor of the Grapevine asked the participants not to sit on articles but to get them in right away. Te discussed the Society's new web site and Associate membership in the Society by active FBI agents. Fred Bragg, President of the FBIAA spoke about Associate membership. He stated that 99% of all FBI agents sign up for the FBIAA at Quantico, during Training class. He discussed Housing allowance for high cost cities, and pension retention for those affected by the 5 year rule. He talked about HR 4132, concerning search warrants on the Hill. He mentioned plans for the FBI's 100 anniversary in 2008. He talked about the availability of \$30 grave markers for retired agents and the problem of theft and local cemetery rules.

MAJOR CASE PRESENTATION - SSA David Reign worked the Enron case for 4.5 years. Billions in losses, Biggest bankruptcy in history. In December 2001 it was the 7th largest company in America. It went up 20% for five years. Holdings were oil, natural gas, wholesale trading, energy contracts, internet and broadband services. Ken Lay - grew up poor. Father was religious. Came from a modest upbringing. He was making 60 to 100 million per year for several years. He testified that he was broke at trial. Stock went down to nothing in six months. Aggressive and fraudulent accounting was the main problem. The trial was four months long. Jeff Skilling was complete opposite of Lay. Both were crooks.

A Communist settled confidently into the witness chair in Manhattan's federal courtroom and started his familiar spiel. Witness Anthony Krchmarek, a minor Communist functionary from Ohio, had come to lend his assurance that the party would not harm even a flea, much less overthrow a Government. He soon found himself talking into the teeth of some expert testimony from a fellow Ohioan: William Cummings, a Toledo auto worker who had spent six years among the Communists as an undercover agent for the FBI.

This was getting to be a familiar experience for defense witnesses in the trial of the eleven top U.S. Communist leaders. U.S. Attorney John F. X. McGohey had kept another witness, Daily Worker Editor John Gates, squirming for six grueling days on that same stand.

After spinning a fine story of what a dedicated idealist he was, Communist Gates had been asked a few pertinent questions. He had testified, had he not, that he was born in New York? Yes. Then McGohey produced a relief application that Gates had once filled out in Youngstown, Ohio, giving Lakewood, N.J. as his birthplace. Had Gates been using that name since 1932? Yes. McGohey fished out a 1937 passport application in which he gave his name as Isriel Ragenstrich. Had Gates not gone to jail twice? Yes. McGohey confronted him with a previous sworn statement, declaring he had never been convicted of a crime.

Expendable Informer. The ordeal of defendant after defendant had become almost a ritual. Backed by the FBI's own underground and the bales of reports which the FBI had been collecting since before World" War II, Prosecutor McGohey often seemed to know more about the Communists and their allies than the 'Reds themselves.

He leaves FBI Headquarters where, since April 2004, he has served as the Inspector/Deputy Assistant Director, Counterterrorism Division.

G-MEN - Not always FBI "G-Men is obviously a contraction of Government men (but) the FBI is by no means the only law-enforcement agent of the U.S, Government." The other agencies whose G-men solve crimes include: Postal Inspectors, Border Patrol, INS, Bureau of Customs, and Secret Service.

FBI SUED - A privacy advocacy group this week filed a lawsuit against Department of Justice after the FBI failed to respond to a Freedom of Information Act request for records concerning electronic surveillance tools, including one that appears to have evolved from the now defunct Carnivore program. The Electronic Frontier Foundation is seeking information on the DCS-3000 and Red Hook programs.

A WEB SITE - is claiming that seven NFL stadiums will be hit with radiological dirty bombs this weekend, but the government on Wednesday expressed doubts about the threat. The warning, posted Oct. 12, was part of an ongoing Internet conversation titled 'New Attack on America Be Afraid." It mentioned NFL stadiums in New York, Miami, Atlanta, Seattle, Houston, Oakland and Cleveland, where games are scheduled this weekend.

FBI DIRECTOR - Robert Mueller on Tuesday called on Internet service providers to record their customers' online activities, a move that anticipates a fierce debate over privacy and law enforcement in Washington next year. "Terrorists coordinate their plans cloaked in the anonymity of the Internet, as do violent sexual predators prowling chat rooms," Mueller said in a speech at the International Association of Chiefs of Police conference in Boston.

JOHN LEWIS SAC PHOENIX

John E. Lewis entered on duty with the FBI at Washington, D.C., on July 25, 1977. Over the next four and one-half years, Mr. Lewis held a series of clerical positions until his appointment to the position of Special Agent on February 21, 1982.

Upon completion of new Agent training, Mr. Lewis was assigned to the Dallas, Texas Field Office, and thereafter to serve the Newark, New Jersey Field Office where he was assigned investigative responsibilities associated with Violent Crimes and Major Offenders, Drugs, White Collar Crime, as well as an assignment to the division's Special Weapons and Tactics (SWAT) Team, Financial Crimes and Public Corruption investigations.

In October of 1989, Mr. Lewis was promoted to Supervisory Special Agent, Undercover and Sensitive Operations Unit, FBI Headquarters, Washington, D.C. This assignment involved national oversight responsibility for various areas of the FBI's undercover program.

In April of 1992, Mr. Lewis was promoted and reassigned to the New Haven, Connecticut Field Office and supervised squads handling Violent Crimes and Major Offenders, Civil Rights vio-



lations, Applicant matters, White Collar Crime investigations, and the FBI's first multi-agency Health Care Fraud task force.

In September of 1996, Mr. Lewis was promoted to Assistant Special Agent in Charge and reassigned to the San Antonio, Texas Field Office. During the assignment, Mr. Lewis was responsible for all facets of FBI field operations to include each of the FBI's investigative and intelligence programs, Applicant and Training programs, Special Operations Group, SWAT, and the division's Support Services branch.

In August 2001, Mr. Lewis was promoted to the position of Inspector and reassigned to FBI Headquarters in Washington, D.C. While in this assignment, Mr. Lewis had responsibilities in the areas of information security, and field office and Legal Attache inspections.

In August 2002, Mr. Lewis was promoted to Special Agent in Charge of the Oklahoma City field office and was responsible for FBI operations in Oklahoma until April, 2004.

In April 2004, Mr. Lewis was promoted to Inspector/Deputy Assistant Director, Counterterrorism Division, FBI Headquarters, Washington, D.C., where he had oversight responsibility in the areas of Domestic Terrorism WMD, Terrorism Financing, and Communications Exploitation.
